MIXING & APPLICATION

- **1.** Add required water to a 5 gal. (18.9 liter) pail as directed by appropriate overlay bag mix TDS.
- 2. Empty SC Color into water prior to addition of dry bag mix.
- 3. Mix with a handheld concrete mixer with a cage mixer blade, such as an Eibenstock model #EHR 20R 4. While mixing add overlay bag mix as directed in appropriate TDS. Note: multiple bag batches may be appropriate; always maintain mix ratio of 1 SC Color (color pack) to 1 overlay bag mix for color consistency.
